



Canada School Recycling Ink Collection Contest

Official Rules and Regulation - 1. CONTEST PERIOD: The Contest start date is April 22, 2014 at 12:00:01 AM EST. Contest closing date is at 11:59:59 PM EST on April 22, 2015. 2. ELIGIBILITY: To be eligible to win the prize, an entrant must be a Canadian elementary or secondary school represented by a school official who is a legal resident of Canada and has reached the age of majority in the province or territory in which he/she resides as of the Contest start date and is not an employee of, Staples Canada Inc. or affiliates, advertising agencies or contractors. Contest is void where prohibited or restricted by law. Contest is subject to all applicable federal, provincial, and local laws and regulations.

- 3. HOW TO PARTICIPATE: Representative on behalf of school must register school at http://www.canadaschoolrecycling.ca/ or http://www.canadaschoolrecycling.ca/?lang=fr-FR to receive a free ink collection bin and automatically be entered into the Contest. From the home page, click 'Register' in the top navigation menu, fill out form and click 'Submit'. Once registered, representative can log in to account and request an ink bin. Once registered, the school is automatically entered into the Contest. The school is encouraged to collect used ink cartridges for recycling in the bin provided. Representative can log in to account and submit a pick-up request of the used ink cartridges. Multiple pick-up requests may be made during the contest period. A UPS shipment label will be provided with each pick up request. All shipments must be postmarked and shipped to Clover Technologies Group by April 22, 2015 to be eligible. All ink collected during the Contest period will be eligible to win one of ten prizes awarded. The ten schools with the largest units of ink cartridges collected will be named the winners of the Contest. Each entry must include all entry information requested in order to be eligible. Limit of one contest entry per school. No Purchase Necessary. All entries become the property of Staples Canada Inc. and Clover Technologies Group. The chances of winning are solely dependent upon the number of eligible entries received. 4. PRIZE: (10) \$1,000 Staples Canada gift cards will be eligible to be won.
